**Bill & Pay** is a new service provided by Pinewood Springs Water District. You can use this tool to view your past bills and any payments you have made or to pay your water bill using Visa, MasterCard, and Discover credit cards, as well as debit cards displaying Visa or MasterCard brand. There is a customer convenience fee of \$3.00 per hundred charged by the credit card processing company. New users please register at [www.ub-pay.com](http://www.ub-pay.com) to access this service. You will need this code **PWSWD540** and your **water account number**. That number can be found in 3 places on your bill. With the warmer temperatures, the snow melt and the forecasted rain, the river looks like chocolate milk. This is called turbidity and happens every year, some years worse than others. The water is tested and treated and is safe to drink, just not very appealing. The color should clear up in a month or so.

## **From Chief Plank:**

The Pinewood Springs Fire Department reminds you to use extra caution around the river, especially in the area of the Tubs. Spring runoff has begun, and the water is high and can be deeper than you may realize. There are tricky currents in and below the Tubs that can make it difficult or impossible to climb out.

With school buildings closed early this year, and many kids home, we ask that parents PLEASE keep kids and pets away from the swift water. For those of you newer to Pinewood, understand that we are approaching the 4-year anniversary of an awful day in Pinewood Springs when two small children drowned in the area of the Tubs- it CAN happen here.

Red rescue cabinets can be found on either side of the river near the tubs, at Crescent Lake and at the Reservoir. The cabinets contain an air horn, life vest (PFD), throw rope and a life preserver. Since cell phone coverage by our water ways may be limited, please sound the air horn to notify neighbors of an emergency and who can then call 911 from their home. Use the supplies provided in the cabinet as best you are safely able to- DO NOT ENTER THE WATER. Just last spring a resident was able to rescue a 20-year old male from the swift current in the Tubs using this equipment.

If you discover that a cabinet has been opened (green pull tab is broken) please notify the Pinewood Springs Fire Department via phone (302-823-5086) or FB.

## **Rules from the Burn Policy:**

- No more slash burning is allowed until Fall, and by permit only
- **No bonfires!** Campfires, outdoor fireplaces, etc. are permitted if they are fully enclosed, including walls and a cover with 1/4" screen or smaller.
- **Fireworks are not** permitted at any time in Pinewood Springs
- **PLEASE CHECK BEFORE USING OPEN FLAME. No open flame is permitted under Red Flag Warning Conditions.**
